## Bazaar Guidelines

1. The person submitting the application is the responsible person for the booth space. They can't share the space with another vendor without the other vendor also filling out an application and listing their merchandise. No extra fees for sharing, we just need to know the who's and what's.
2. Vendors will not leave parties not listed on their form, in charge of their space and minor children are not to be left manning the space without an adult.
3. The Bootjack Stompers will advertise in Mariposa Gazette, social media and flyers in the surrounding communities. The Bootjack Stompers encourage vendors to help spread the word on this event. 4. Bootjack Stompers reserves the right to exclude the sale of inappropriate merchandise.
5. Bootjack Stompers reserves the right to limit the number of vendors selling similar merchandise.
6. Please be considerate of other vendors.
7. Please have at least 50% of your display showing hand crafted items.
8. Please park in the lower parking area unless you have physical limitations. Feel free to move your vehicle closer for loading and unloading.
9. Windows will be covered, building secured and extra patrol requested overnight. Items left overnight are not the responsibility of the Bootjack Stompers nor it's members.
10. Pack-up can begin no earlier than 15 minutes prior to the end of the bazaar and do not carry stuff out until after 4pm.
11. Vendor space needs to be cleared of all trash before you leave. Please be sure any spills are cleaned immediately. Use extreme caution on the hard-wood floors.
12. Payment is due with registration form to reserve the booth space. (Please keep in mind that we have made the spaces larger, therefore there are fewer spaces. If registration form and payment is not received early, vendor might not get a space in their preferred area.)
13. Vendor is responsible for any licensing, or permits for the items they are selling. Food sales require proper Health Department permits. The kitchen is not commercial, but you can get Health Department approval for some uses.
14. Vendor will not hold Bootjack Stompers Square Dance Club or any individual working with the bazaar responsible for personal injury, damage to property, or theft, nor will the vendor be a party to any legal action against the Bootjack Stompers Square Dance Club or members.
15. The registration fee is non-refundable once the application has been accepted.
16. Internet is not provided. We are in Verizon service area if you wish to bring your own hot-spot.
17. All fees will be refunded if we are required to cancel due to Covid (or other disaster).
18. Vendors are expected to be aware and comply with local, state and federal laws and Covid requirements.
